**Review the medical records.** The medical records provide the framework for every workers' compensation case. Therefore, it is essential that you are fully familiar with every aspect of your documented treatment. Often the events discussed occurred months or even years earlier and resist recall. Thorough review of the records augments your ability to explain what was said and done and the rationale behind the treatment you provided. Being unfamiliar with your own care can irreparably damage the client's case and your reputation.

## Dangers of Generic Prescription Drugs

As health care reforms are becoming a large part of the current economic condition and political platform, it is interesting to look at last year's Supreme Court ruling in the case Pilva, INC v. Mensing, 131 U.S 2567 (2011). This case combines two separate lawsuits against generic prescription manufacturers, in which the patients argued that the prescriptions for the generic version of Reglan failed to satisfy state tort laws that require manufacturers who are or should be "aware of its product's danger to label that product in a way that renders it reasonably safe." Both patients were diagnosed with a severe neurological disorder after long-term use of the generic version of Reglan.

After numerous appeals at the state and federal level, the cases made their way to the Supreme Court, which reversed the lower courts' decisions citing the manufacturers responsible for inadequate warnings on the drugs' safety. The Supreme Court decision states that the manufacturer of generic drugs cannot be held liable for inadequate warning labels. This is because the FDA requires that generic drugs maintain the same label as their brand name counterpart, as outlined by the 1984 Drug Price Competition and Patent Term Restoration Act, 98 Stat. 1585, more commonly known as the Hatch-Waxman Amendment. Since generic manufacturers cannot control the label warning without breaking federal law, they cannot be held responsible under state

tort laws.

However, the FDA does allow generic drug manufacturers to petition for label changes to be made. The FDA investigates the accuracy of the proposed changes and works with the brand name manufacturer to implement a new warning. If a new warning label is agreed upon, the generic drugs will then be made to carry it. The problem is that in the United States most states have statutes that allow pharmacist to substitute the brand name for a generic version, including Pennsylvania.

With the generic version

being available at a cost-friendly option to both pharmacies and patients, they become the more popular choice. Recent studies have shown that about 80% of the prescriptions filled in the United States are with generic versions.

# Legislative ALERT!

The PA Chamber of Commerce proposed changes to the workers' compensation system earlier this year. The changes were "designed to get medical costs under control, improve quality of care and curtail waste and abuse in the current WC system." These proposals will not be passed this year but we can expect that in January



when the new legislature is sworn in that a bill will be introduced in both the State Senate and House. The Chamber of Commerce bill, if passed, will restrict the rights of both patients and medical providers in workers' compensation cases.

The proposed "reforms" include extending the time treating with panel providers from 90 to 180

days; removing the workers' compensation judge from utilization reviews; annual modification to fee schedules and the addition of a prescription benefits manager.
