Mr. Wilson has served on the Workers' Compensation Law Section Council of the Pennsylvania Bar Association since 2007 and is a past Chair of the organization. He is a member of the committee that implemented and manages a ground breaking certification process for Pennsylvania workers' compensation attorneys. He is an active member of the Pennsylvania and Philadelphia Trial Lawyers Associations as well as the Workers' Injury Law & Advocacy Group. Mr. Wilson was inducted into The College of Workers' Compensation Lawyers in 2011. In 2017, Mr. Wilson was named Best Lawyers 2017 Workers Compensation Law - Claimants, "Lawyer of the Year" in Philadelphia. He was also recognized by The Workers' Injury Law & Advocacy Group's Top Injured Workers' Attorneys. Mr. Wilson is the 2018 award recipient of the Irvin Stander Memorial Award by the Pennsylvania Bar Association. This award is presented annually to an attorney whose dedication to workers' compensation law and professionalism serves as an example to others.
